- 1 The above results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on January 29,2020 The Statutory Auditors have carried a Limited Review on the above Financial Results.
- 2 Financial results for all the periods presented have been prepared in accordance with the recognition and measurement principles of Ind AS notified under the companies (Indian Accounting Standards) Rules, 2015 as amended from time to time.
- An amount of Rs.227.85 lakhs representing disputed redemption money on 35,00,000 units of "Risk Guardian 95" is held by the Company in trust to the rightful owner when the dispute is settled by the appropriate court/forum. This amount has been deployed in NCD now (earlier in subordinate bond) and along with interest accrued thereon, the present value of which is Rs. 1373.25 lakhs (net of tax). The disputed amount of Rs.227.85 lakhs along with the interest accrued thereon has been recognised in the accounts as payable to the rightful owner.
- 4 The principal business of the Company is being Investment Manager of Shriram Mutual Fund. Further, all activities are carried out within India. As such, there are no separate reportable segments as per the Indian Accounting Standard 108 (Ind AS) on 'Operating Segments'.
- 5 The Company has adopted Ind AS 116 'Leases', effective annual reporting period beginning April 01, 2019 and applied the standard to its leases. This has resulted in recognising a right- of-use asset and a corresponding lease liability of Rs. 71.11 lakhs as at December 31, 2019. The impact on the profit for the quarter is Rs.NIL.

The figures for the corresponding previous period have been regrouped/ reclassified wherever necessary, to make them comparable.
